England Rugby Travel ("**ERT**") are offering ERT customers the chance to win access to a pre-Rugby World Cup event which will be held on the 28<sup>th</sup> April 2023. To enter this competition, you must:

- Book an ERT Rugby World Cup 2023 Package for the final of the Rugby World Cup 2023 ("**Final Package**"); or, Book an ERT Rugby World Cup 2023 Package which includes the England v Japan game ("Japan Package") together eligible packages ("**Eligible Packages**"); and,
- Be one of the first 50 party members on Eligible Packages sold after 00:00 on the 22<sup>nd</sup> February 2023 ("**Start Date**").

We will contact the lead booker of the Eligible Package(s) via email if they are a winner.

## **TERMS & CONDITIONS**

- 1. The promotion is open to customers of ERT who are residents of England and Wales over 18 years of age. Employees, friends and relatives, and associated third-party suppliers of ERT are not permitted to enter the competition.
- 2. ERT Package Terms & Conditions will apply to the purchase of the Eligible Package without variation. You must fully comply with these terms. These can be viewed at <u>https://rwc.englandrugbytravel.com/terms-and-conditions/</u>.
- 3. The promotion is available from Start Date until the first 50 party members for Eligible Packages are sold or 23:59 on 31<sup>st</sup> March 2023, whichever occurs first ("End Date"). Packages purchased before the Start Date or after the End Date are not eligible for this promotion.
- 4. You must purchase a Eligible Package as no other packages are eligible for this promotion.
- 5. If you are a lead booker and have purchased more than one Eligible Package, each party member on the Eligible Package purchased will be counted in the first 50 Eligible Packages to be sold. For example, if the first customer to purchase a Eligible Package after the Start Date purchases Eligible Packages for 10 party members, then only the next 40 party members booked on Eligible Packages will be eligible for the prize.
- 6. If you are a winner this will mean the lead booker and party members will have access to the pre-Rugby World Cup event, provided that the Eligible Packages were purchased at the same time.
