

## WAIT FOR US AND WE'LL REWARD YOU – TERMS & CONDITIONS

England Rugby Travel (“**ERT**”) are offering the chance to receive the benefits described below (the “**Offer**”). To participate, entrants must purchase a Rugby World Cup 2027 (“**RWC27**”) package before 31st March 2027 at 12:00pm UK time (a “**Qualifying Booking**”).

Please see the terms and conditions below that apply to this Offer.

### PLEASE NOTE

#### INFORMATION REGARDING DATA COLLECTION

Information collected from entrants will be processed in accordance with ERT's privacy policy <https://rwc.englandrugbytravel.com/privacy-policy/>. We will need to collect and use your data in order to notify you if you are a winner of a prize.

### OFFER

There are three separate benefit types:

#### A. Complimentary Warm-up Match Ticket (“**Ticket Inclusion**”)

The Lead Booker will be eligible to receive one complimentary ticket for each party member included in the Qualifying Booking to an England Rugby World Cup warm-up match prior to RWC27, selected by ERT, when the Lead Booker makes a Qualifying Booking, provided that the Qualifying booking is made no later than 31<sup>st</sup> March 2026 at 12:00pm UK time (the “**Ticket Inclusion Deadline**”). For the purposes of this Ticket Inclusion, “party member” means each individual named on the booking confirmation for the Qualifying Booking at the time ERT allocates the tickets.

If eligible for complimentary tickets, ERT will notify the Lead Booker of the match to which the complimentary ticket relates. If the Lead Booker declines the offer of the complimentary ticket, no ticket will be provided, and this benefit shall expire.

No additional compensation, cash or other alternative in part or full will be offered in lieu of the Ticket Inclusion, including where the relevant match is cancelled, postponed or rescheduled, or where ERT withdraws the Ticket Inclusion in accordance with these terms.

If the relevant match is cancelled, postponed or rescheduled, or if ERT is unable to provide the ticket for reasons beyond its control, ERT may (at its discretion) provide a ticket to an alternative match of equivalent value or withdraw the ticket inclusion, and ERT shall have no further liability to the Lead Booker in respect of the ticket inclusion.

#### B. Signed England Shirt Prize Draw

Five winners will each receive one signed England Rugby shirt signed by the England Rugby squad from the 2026/27 season (“**Signed Shirt Prize**”).

Total number of Signed Shirt Prizes: 5.

Each Qualifying Booking will automatically be entered into a random prize draw for the Signed Shirt Prize (the “**Signed Shirt Prize Draw**”).

The Signed Shirt Prize can only be posted to registered addresses in the United Kingdom and will be sent by standard post. Given the package size, someone will need to be at the address to take receipt.

#### C. “Win back the full cost of your package” Prize Draw

One winner will win back the full price paid by that winner for their eligible package booking, as shown on the final balance invoice issued by ERT to the Lead Booker in respect of the winning Qualifying Booking (the “**Package Refund Prize**”), up to a maximum of £50,000, excluding any additional charges resulting from amendments or changes to the package, and any administration fees. The refund will be

paid by bank transfer or refunded to the original payment method of the Lead Booker (at ERT's sole discretion) within 60 days of verification.

Each Qualifying Booking will automatically be entered into a random prize draw (the "**Package Refund Prize Draw**") for the relevant prize.

B and C will be collectively known as "**the Prize Draws**" and signed shirt and refund collectively as "**the Prizes**".

## **TERMS & CONDITIONS**

1. This Offer will run from 3rd February 2026 at 10:00am UK time until 31<sup>st</sup> March 2027 at 12:00pm UK time.
2. This Offer is open to residents of England and Wales over 18 years of age except employees, friends and relatives, and associated third-party suppliers of ERT.
3. To participate in this Offer, entrants must make a Qualifying Booking. There is one entry per booking.
4. A booking may be a Qualifying Booking for the purposes of the Prize Draws even if it is made after the Ticket Inclusion Deadline, but such booking will not be eligible for the Ticket Inclusion.
5. The Offer is separate from, and does not amend, the terms and conditions that apply to the purchase of any RWC27 package (the "**Package Terms**"). In the event of any conflict between these Offer terms and the Package Terms, the Package Terms will prevail in relation to the package purchase, payment, cancellation and refund, and these Offer terms will prevail in relation to the administration of the Offer and the awarding/fulfilment of the Ticket Inclusion and the Prize Draws.
6. ERT may refuse entries to the Prize Draws at its discretion if they appear to be dishonest, defective, in breach of the rules, forged or in bad faith. Incorrect entries will not be included in the draw. Entries are valid only while the Qualifying Booking remains valid and fully up to date; if the Lead Booker is behind on payment, or the booking is cancelled, refunded (in whole or in part) or charged back, the Lead Booker and all party members are excluded from the Offer and any entry will be void.
7. The winners of the Prize Draws will be drawn at random by an independent third party on 1<sup>st</sup> December 2027 at 12:00 UK time and will be notified within 7 days of the date of the draw.
8. The winners of the Prize Draws will be contacted by email and/or phone call, using the contact details supplied when booking the package, to inform them that they have won on and must claim their prize within 7 days of being notified; otherwise, the right to claim the prize will be lost.
9. No cash or other alternative in part or full will be offered in lieu of the Signed Shirt Prize. The Signed Shirt Prize is non-transferable. The Package Refund Prize is a reimbursement of the package price paid by the winner (up to the stated cap) and is not transferable. ERT accepts no responsibility for entries which are lost, delayed or not received.
10. ERT's decision is final, and no correspondence will be entered into.
11. If any circumstances out of ERT's control mean that a prize advertised is not available, ERT will provide a prize of equivalent value.
12. Events may occur or render the Prize Draws or the awarding of the prizes impossible due to reasons beyond the control of ERT. If such an event occurs ERT shall not be liable to the entrant or winner.
13. ERT reserves the right in its absolute sole discretion to amend, alter or terminate the Offer at any time due to circumstances beyond its control.

18. Entry instructions for specific Offers are deemed to form part of the rules as are these terms and conditions. By participating in this Offer, entrants confirm they have read, understood and agreed to be bound by these terms and conditions.

If any provision or part of these terms and conditions is or becomes invalid, illegal or otherwise unenforceable, it shall be deemed deleted, but that shall not affect the validity and enforceability of the rest of these terms and conditions.
